# For what do we use your personal information?

The initial purpose is to contact you to send union information, know your opinion and know your employment situation as an affiliate and worker, your working conditions, manage your requests and the services that you request expressly (training, legal advice, legal defence, requests, etc) and in case, as an affiliate, manage your relationship with the trade union.

# For how long will we retain your personal information?

For like all affiliate we will keep your personal information as long as we have your approval to keep this information and as long as the person concerned do not request cancellation. Likewise, once finished the relationship, we will block your personal data until the legal requirements that are four years (4) for the general tax regulations. Once finished this period, we will destroy your details. Also, the legal files of the affiliates will be accessible in case of resolution of future cases for their analysis and studies, in case judicial services may retain this information relevant. In any case, we will keep them for the time necessary to fulfil the purpose for which the personal data were requested or to receive and to determine the possible responsibilities that may arise from this purpose and the processing of the data, without prejudice to the aforementioned right of deletion.

# For what reason do we use your personal details?

The legal basis that allow us using your private details are:

- 1. To accomplish the rights as an affiliate in La Intersindical-CSC
- 2. When you expressly give your consent. You can withdraw your consent anytime sending an email to: dretsprotecciodades@intersindical-csc.cat.
- 3. For legitim purposes of La Intersindical-CSC, always respecting your rights of data protection your honour and your personal and family privacy, using techniques for that no one could identify you. Anytime you can appose to this by sending an email to: dretsprotecciodades

# To who we will communicate your data?

Your data will not be communicated to third parties, except if we are obligated by law or if you give us your consent. The information could be given to the company, public authorities, authorities and entities or companies involved with public or private services depending on the object of the processing.

In order to provide you with a suitable service and manage our relationship, we contract web hosting services, domain name registration, servers, electronic messaging service, with the person in charge treatment LANA2 (<a href="https://www.lana2.net">https://www.lana2.net</a>) and Mailchimp platform, with tools used for the management of email marketing (campaigns, surveys, etc). In charge of all this is The Rocket Science Group (The Rocket Science Group, LLC, 675 Ponce de Leon Ave NE, Suite 5000, Atlanta, GA 30308, USA (<a href="https://mailchimp.com/contact">https://mailchimp.com/contact</a>). When, through the companies in charge of personal data processing, we carry out international data transfers, we ensure that they always comply with all technical and organizational security measures, specifically with the clauses standard contracts, required by the privacy and personal data protection regulatory framework of the European Union. # Deletion

You can request to delete your personal details.

You can request for your data not to be used.

# Limitation of data processing

You can request the limitation on processing your data in these cases:

- When you realize that the data is not correct,
- When the treatment is unlawful, but you object to the deletion of your data
- When we do not need to process your data, but you need it for the exercise or defense of claims
- When you have objected to the processing of your data for the fulfillment of a public interest mission or for the satisfaction of a legitimate interest, while it is verified whether the legitimate reasons for the treatment prevail over yours.

# Portability

You can receive, in electronic format, the data that you have shared with us and send it to another organisation.

# Important

- To exercise your rights, you can do so by writing to the address dretsprotecciodades@intersindical-csc.cat. In some cases, the data controller may request that accompany your request with a copy of a document proving your identity (your NIE or passport),

- The exercise of the rights of limitation to treatment and portability is free of charge.
